SUMMON

WHEREAS, in connection with the **APIC-No. 34/2026**, your personal appearance is required before the Commission on **23rd July, 2026 at 10:30 AM**. The Appellant Shri Tamchi Gungte is present during the hearing before the Commission.

The PIO-cum-EE, PHE & WS, Hawaii Division, Anjaw District, Govt. of Arunachal Pradesh is absent without reporting the reason for his absence.

Heard the Appellant;

The Appellant stated that PIO had written him a letter dated 18.12.2025 to collect the information, but as he did not receive the letter on time and he filed the first appeal before the First Appellate Authority (FAA) wherein the hearing for the first appeal was fixed on 16.01.2025 at Namsai, for which he got the notice for the hearing on the same date on 16.01.2025 at Itanagar, therefore, he could not attend the hearing, after that no communication from the PIO nor from the FAA have been received, therefore, he filed the second appeal before the Arunachal Pradesh Information Commission (APIC).

After hearing the Appellant and in the absence of the PIO the Commission adjourned today's hearing with the following orders;

- i) Send Summons to the PIO to attend the next date of hearing without fail, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- ii) The Appellant to be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.
- iii) Send the notice for the next date of hearing along with the Summons to the PIO.
- iv) Notice for the next date of hearing need not be sent to the Appellant as he is present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 23rd day of July' 2026 at 2:30 PM (Evening).
