SUMMON

WHEREAS, in connection with the **APIC-No. 632/A/2025**, your personal appearance is required before the Commission on **29th October, 2026 at 10:30 AM**. The 3rd hearing held on **20th August' 2026**. The Appellants Shri Ruba Sakmi and Bengia Tahar are absent without reporting the reason for their absence to the Commission.
