SUMMON

WHEREAS, in connection with the **APIC-No. 90/2026**, your personal appearance is required before the Commission on **5th November, 2026 at 10:30 AM**. The 1st hearing held on **25th August' 2026**. The Appellant Shri Tamchi Gungte is present during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), RWD, Lumla Division, Tawang District, Govt. of Arunachal Pradesh is absent without reporting the reason for his absence

Heard the Appellant;

After hearing the Appellant the Commission hereby observes;

- i) That the PIO-cum-EE, RWD, Lumla Division, Tawang District, Govt. of Arunachal Pradesh had brought the information(s) to be provided to the Appellant at the office of the Arunachal Pradesh Information Commission (APIC) and it is under the custody of APIC now.
- ii) The information submitted before the APIC by the PIO shall be handed over to the Appellant today after this hearing is finished.

Under the above observations the Commission hereby orders;

- a) The Appellant to collect the information provided by the PIO from the office of APIC after this hearing is finished, today itself.
- b) The Appellant to be present in the next hearing without fail, to let the Commission know whether the information provided by the PIO are complete or not, and therefore, the Appellant to be present in the next hearing without fail, failing which the Commission will presume that the Appellant has been furnished with the

complete information by the PIO and this appeal will be heard and determined ex-parte, by way of disposing it.

- c) The PIO to be present in the next hearing without fail, failing which necessary action as provided under RTI, Act, 2005 shall be initiated against the PIO.
- d) Notice for the next hearing need not be sent to the Appellant as he is present today in the court.
- e) Notice for the next date of hearing be sent to the PIO.

The Commission hereby orders;

The next date of hearing be fixed on 5th day of November' 2026 at 10:30 AM (Morning).
