**NOTICE**

The 1<sup>st</sup> hearing held on 7<sup>th</sup> July' 2026' related to the APIC No-279/A/2026. The Appellant Miss Bengia Mama is present during the hearing before the Commission.

The PIO-cum-Executive Engineer, (EE), PWD, Raga Divisio, Kamle District, Govt. of Arunachal Pradesh is represented by Shri Lingdon Nikte, Junior Engineer (JE) PWD, Raga, Kamle District, Govt. of Arunachal Pradesh during the hearing before the Commission.

**Heard the Appellant;**

The Appellant stated that the PIO has not provided any information to her till date.

**Heard the representative of the PIO;**

The representative of the PIO stated that to provide for the expenditure, Pay Bill, LOC for payment of TA/DA/TTA, copy of expenditure bill of OC, POL and OE, Copy of Work Order, Supply Order for a whole year cannot be provided to the Appellant in five or six months also as the information(s) sought are too voluminous, and further submitted before the Commission to give ample time to the PIO to provide the information(s) as sought by the Appellant.

After hearing both the parties the Commission hereby order as follows;

- i) The PIO to provide the information(s) to the Appellant on or before the next date of hearing, and attend the next date of hearing without fail, failing which necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.
- ii) The Appellant to collect the information(s) from the office of the PIO and intimate the Commission to let know the complete receipt of the information(s) from the PIO and attend the next date of hearing without fail, failing the commission will presume the PIO has furnished all information to the Appellant, and thereby, disposing of this appeal ex-parte.
- iii) Notice for next date of hearing need not be issued to both the parties as they are present during the hearing before the Commission.

Commission hereby orders;

The next date of hearing be fixed on 05<sup>th</sup> day of November 2026 at 10:30 AM (Morning).

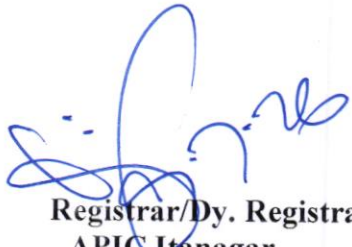
