An Appeal Case U/S 19(3) of RTI Act, 2005

ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the EE (RWD), Mechuka Division, Shi Yomi District as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 27.09.2025.

A. Particular of information: C/o " Plan & Non-plan Works/projects sponsored by State fund/Central fund or both (such as SIDF/ BE/ RE/ RIDF/ SADA/ ADA/ MLA-LAD/ MP-LAD/ SPA/ Article 275(1)/ PMJKV erstwhile MsDP/ CRIF/ PM-DeVINE/ NEC/ NESIDS/ Non-BADP/ SASCI/ VVP/ PMGSY/ Maintenance works etc.) executed under the concern division" from the financial year 2015-16 to 2025-26.

B. Details of information required:

1. Copy of Total List of Completed Projects/works (Plan & non-plan) in which the Security Deposits has been refunded to the contractors (submitted in FDR etc. and deducted from each running bill and final bill @2.5% minimum of the gross amount of Bill) under the division for each financial year from 2015-16 to 2025-26 with proper date of completion details.
2. Copy of Register Of Security Deposit Form CPWA-67 maintained in the Division for each financial year from 2020-21 to 2025-26 in respect of serial No. 1 mentioned above for each financial year from 2015-16 to 2025-26.
3. Copy of Refund of Security Deposit (along with supporting documents of refund) to the Contractors as per agreement made in Forms CPWD 7 & 8 on the completion of works regulated by Clause 17 of GCC in respect of serial no.1 mentioned above for each financial year 2015-16 to 2025-26.
4. Furnish all the above documents with CTC & proper manner (i.e. in serial wise with properly Index, proper paging of each financial year and separate books for each financial year for easy & better understanding).

Records emerging from the appeal:

Records in the appeal reveal that the appellant, Shri Tamchi Gungte, vide his RTI application dt.27.09.2025, had requested the PIO for the aforementioned information but failed to obtain the same which prompted him to file his 1st appeal before the Chief Engineer(PWD) Western Zone, Itanagar the First Appellate Authority (FAA) under section 19(1) of the RTI Act vide Memo of Appeal dt. 15.01.2026.

Records further reveal that the FAA had attempted to conduct the hearing by issuing summon notice dt.28.01.2026. But there is no further record as to whether the FAA had conducted the hearing and the order, if any, passed thereon.

The appellant has, however, filed his 2nd appeal before this Commission under section 19(3) of the RTI Act vide his Memo of Appeal dt.13.03.2026 on the ground that the PIO did not furnish the requested information nor did the FAA conduct the hearing of the appeal.

This appeal is, accordingly, registered in the Commission and listed for hearing today on 19.08.2026. But none of the parties are present though the appellant has informed this Commission vide his letter dt.18.08.2026 that due to his pre-occupation in SIR hearing, he shall not be able to attend the hearing today and requested for adjournment of the hearing.

The hearing of this appeal is , therefore, adjourned to 25.09.2026 and in the interim, the PIO is directed to furnish the requested information to the appellant and report the compliance thereof on 25.09.2026.
