SUMMON

WHEREAS, in connection with the **APIC-No. 649/2025**, your personal appearance is required before the Commission on **27th October, 2026 at 02:30 PM**. The **3rd** hearing held on **18th day of August' 2026**. The Appellant Shri Chow Lajamang Mannow is absent during the hearing without reporting the reason for his absence.

The PIO-cum-Chief Engineer (CE), (Coordination), PWD, Itanagar, 'O' point, Itanagar, Papumpare District, Govt. of Arunachal Pradesh is absent for the consecutive 3rd time, despite notice for hearing sent to his office on 24.09.2025, 16.10.2025 and 24.02.2026.

- 4) The copy of this Bailable Warrant of Arrest be served to the Superintendent of Police, Itanagar Capital Region, Papumpare District, for compliance.
- 5) The copy of this Bailable Warrant of Arrest be served to the Deputy Commissioner, Capital, Papumpare District, for information.
- 6) Notice for the next date of hearing be served to the Appellant.

The Commission hereby orders;

The next date of hearing be fixed on 27th day of October, 2026 at 2:30 PM (Evening).
