**ORDEER/SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Ms. Bengia Mama for non-furnishing of below mentioned information by the PIO, o/o the BDO CD Block Basar, Leparada District as sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide her application dated 19.01.2026.

**A) Particular of information:** construction of approach road for EMRS, Tirbin in Leparada District.

**B) Total Sanctioned Amount:** Rs. 300.00 Lakhs

**C) Details of information required:**

1. Furnish a copy of Sanction Order.
2. Furnish a copy of the Details Project Report (DPR).
3. Furnish Work order
4. Furnish TS copy
5. Furnish a copy of Geo-Tagging details in colouring photos.
6. Furnish a copy of the Photograph of project before during and after the completion of the project in coloring photo.
7. Furnish a copy of the Payment Cheque leaf/PFMS/DBT transaction receipt copy.
8. Furnish a copy of Letter of Credit (LOC).
9. Furnish a copy of Notice Inviting Tender (NIT) details with NEWS paper cutting. The name of the NEWS paper and date of the publication must be clear and visible.
10. Furnish a copy of the Name of the Officers involved in the said project.
11. Furnish a copy of the Name of bidder or winner Firm with detail supporting technical bid documents of the winner Firm (Bidder).
12. Furnish a copy of the Name of all the tender participants along with detail technical documents submitted by the participants.
13. Furnish a copy of the details of physical inspection report along with coloring photos of site visits during physical inspection by the Nodal Department, Directorate Office, SJETA Itanagar.
14. Furnish copy of the contractor licenses of the selected bidders, including the date of registration and any relevant updates or renewals.
15. Furnish a copy of GST return 3B filed of all the Suppliers/ contractors before releasing payment.
16. Furnish a copy of CA BOOK (Contract Agreement Book).
17. Furnish a copy of the details on the grounds for rejection of the technical bids of all bidders who were disqualified in the evaluation process. This should include specific deficiencies or no-compliances with the tender requirements.

18. Furnish a copy of Quarter Project Report (QPR).
  19. Furnish a copy of the MOU or Agreement signed between Department and Proprietor/contractor.
  20. Furnish a copy of MIS Report.
  21. Furnish a copy of detail copies of Material Procurement of Challans.
  22. Furnish Completion Certificate.
  23. Furnish Utilization Certificate.
  24. Furnish a copy of MB (Measurement Book) details.
  25. Furnish a copy of the Display Board. The Display Board must be showing the name of the Scheme, Sanctioned Amount, Nodal Department, funding Agency etc.
  26. Furnish all the documents viz: Acknowledgment Letter, Challan letter etc. in the above mentioned address through register Post.
  27. Furnish all the documents in proper paging with CTC in each page and please to furnish within 30 days from the date of receipt.
- D) Period for which information is sought for: 2025.**

**Facts emerging from the appeal:**

Records in the appeal reveal that the appellant, Ms Bengia Mama had requested the PIO for the aforementioned information but failed to obtain the same which prompted her to file her 1<sup>st</sup> appeal before the Director, Social Justice, Empowerment and Tribal Affairs Department as the First Appellate Authority (FAA) vide her Memo of Appeal dt.17.02.2026 but she failed to receive any response from the FAA also. The appellant, therefore, filed her 2<sup>nd</sup> appeal under section 19(3) of the RTI Act before this Commission vide her Memo of appeal dt.13.04.26 on the ground that the o/o the PIO refused to receive her RTI application dt.19.01.2026.

This appeal is, accordingly, registered in this Commission and listed today on 19.08.2026 wherein the PIO, Ms. Papki Karlo, BDO, CD Block, Basar is present through VC but the appellant, vide her letter dt.17.08.26, intimated that she would not be able to attend the hearing on 19.08.26 due to her pre-occupation in the SIR hearing and pleaded for adjournment of the hearing.

Heard the PIO, who informed that her office has come to know about the appeal along with the RTI application in question only a few days back and therefore, she pleaded for one or two months time to furnish the requested information to the appellant.

As prayed for the PIO is allowed 45(forty five) days time from the date of receipt of this order to furnish the requested information in a tabular form with proper paging and indexing to the appellant and report compliance thereof to this Commission on 07.10.2026, the next date of hearing.

**NOW THEREFORE**, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on 07.10.2026 (Wednesday) at 10.30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined, including closure of the appeal, in your absence.
