**WARNING SUMMON**

**WHEREAS**, in connection with the **APIC-No. 306/2024**, your personal appearance is required before the Commission on **5<sup>th</sup> November, 2026 at 10:30 AM**. The **5<sup>th</sup> hearing held on 25<sup>th</sup> August' 2026**. The Appellant Shri Sama Yangfo, present during the hearing and the PIO -cum Executive Engineer ( RWD) Bameng Division Govt. of Arunachal Pradesh, Shri Sangkoli Cheda, absent with intimation that his mother has died day before yesterday, and therefore, as per rituals he is to stay at home without meeting anyone in the outside during the restricted period of 5(five) days.

**Heard the Appellant.**

The Appellant stated that no information have been provided to him by the PIO till today. The previous Assistant Engineer (AE), now is promoted as Executive Engineer (EE) and holding the office of the PIO.

And therefore, it won't be a difficult task for the present PIO to provide him the information if the office of the PIO is serious enough to provide information to him

In the absence of the PIO, the details for the information as to why he has not provided to the Appellant till now could not be ascertain and so the hearing adjourned, while considering the absence of the PIO on reasonable cause.

**Considering the absence of the PIO and after hearing the Appellant the Commission hereby order as follows;**

- i) The PIO to provide the information to the Appellant on or before the next hearing.
- ii) The Appellant to be present in the next hearing without fail, **failing which this appeal will be heard and determined ex-parte.**
- iii) The PIO to be present in the next date of hearing without fail, **failing which disciplinary action against the PIO will be initiated as per the RTI Act 2005.**
- iv) Notice for the next hearing need not be sent to the Appellant, as he is present in the court today and send notice for the next hearing to the PIO.

The Commission hereby orders;

The next date of hearing be fixed on 5<sup>th</sup> Nov 2026 at 10:30 AM (Morning)
