This is a complaint under Section 18(1) of RTI Act, 2005 received from Ms. Sonia Raba for non furnishing of below mentioned information by the PIO o/o the EE Department of UD & Housing Capital Complex Division, Itanagar as sought for by her under section 18(1) (Form-A) of RTI Act, 2005 vide her application dated 07.05.2026.

Facts emerging from the Complaint and the decision:

Facts emerging from the complaint in question reveal that the complainant, Ms. Sonia Raba, submitted her RTI application in FORM-A dt. Nil, along with IPO No.71F 517433 dt.07.05.2026 for Rs 10 being the RTI application fee. However, the o/o the PIO, vide letter dt.08.05.2026 signed by the APIO-cum-ASW (UD), Capital Complex (as reproduced hereunder) had advised the applicant/complainant to deposit the application fee through e-grass portal as per Govt. of A.P instruction contained in order dt.17.12.2024.

"Sub:-Returning IPO

Sir,

This office has received your application no. Nil Dated 7 April 2026, in Form "A" Vide letter No. Nil IPO No.71F517433 Dated 7 April 2026 Seeking the information regarding the work "C/O RCC Protection Wall at Dariya hill colony. Itanagar Repairs" under RTI Act 2005.

In this regard, it is to inform you that the Govt. of Arunachal Pradesh has started the collection of all Government fees, Revenues and other receipts electronically through e-Gras portal w.e.f, 1st January 2025 vide order No. SPMU-17/14/2021(E 15204) dated 17 October 2024.

Therefore you are requested to deposit the application fees into the head of account No. 007-60-118-00-00 through e-Gras portal to furnish the information.

The applicant/complainant, feeling aggrieved, with the response of the o/o the PIO as above, preferred this complaint under section 18(1) of the RTI Act, 2005 on the ground that the PIO has refused to accept the IPO saying that the fee shall be accepted only through e-grass.

This complaint is, accordingly, listed today on 21.08.2026 wherein the applicant/complainant, Ms. Sonia Raba is present in person while Er. Shri Taylor Tache, EE appeared through VC who submitted that he has been wrongly summoned by this Commission in this case and further stated that there are 2(two) UD and Housing Divisions at Itanagar viz. the Itanagar Division of which he is the Executive Engineer and another Division, the Capital Complex Division headed by some other Executive Engineer. On a pointed query, the E.E replied that his Division (Itanagar) did not execute the project in question i.e the c/o RCC Protection Wall at Dariya Hill colony Itanagar with respect to which the aforesaid 24(twenty four) point information have been sought by the appellant, Ms. Sonia Raba.

This Commission, after hearing the E.E, Taylor Tache and the appellant found that the summon notice has, indeed, been served to the wrong Public Authority and PIO.

In the premises as above, this Commission concludes that the PIO, o/o the E.E, Capital Complex Division should be heard and accordingly, summon him for adjudication of this complaint and as such this complaint case is posted on 23.09.26.
