WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 321/2025**, your personal appearance is required before the Commission on **17th September 2026 at 10:30 AM**. The 4th hearing held on **9th July' 2026**. The Appellant Shri Bagemso Mitti is present through online mode during the hearing before the Commission.

The PIO-cum-Divisional Forest Officer (DFO), Tezu Lohit Division, Lohit District, Govt. of Arunachal Pradesh is absent despite notice for today's hearing served unto him for his presence in the court in the last hearing on 23.04.2026.

Heard the Appellant;

The Appellant stated that he had visited the office of the PIO personally but could not meet the PIO nor get the information from any staff of the office of the PIO.

After hearing the Appellant and taking the absence of the PIO seriously, the Commission hereby order as follows;

- i) Warning Summons be issued to the PIO to be present in the next date of hearing without fail to explain the reason why the information have not been provided to the Appellant till now despite committing to provide the information(s) to the Appellant before the court of the Commission on 23.04.2026. In the event of absence in the next hearing the PIO shall be arrested and brought before the court of this Commission.
- ii) The Appellant to pursue the office of the PIO to obtain the information(s) from the PIO's office. Further the Appellant is hereby ordered to be present in the next date of hearing without fail, failing which the Commission will presume that the Appellant has received the information completely from the PIO, and thereby, this appeal will be heard and determined ex-parte by way of disposal of this appeal.
- iii) Send notice for next date of hearing along with the Warning Summons to the PIO.

- iv) Notice for the next date of hearing need not be sent to the Appellant as he is present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 17th day of September' 2026 at 10:30 AM (Morning).

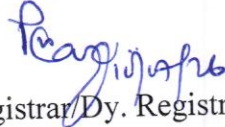
