



**ARUNACHAL PRADESH INFORMATION COMMISSION, APIC

An Appeal Case U/S 19(3) of RTI Act, 2005.
Vide Case No. APIC-03/2026

Shri Tamchi Gungte -V/S- PIO-Cum-EE, PWD, Changlang District A.P.

ORDER

The 1st hearing held on 12th May'2026, related to the APIC No-03/2026 (Appeal). The Appellant Shri Tamchi Gungte present during the hearing and the PIO –cum EE (PWD) Changlang Division, represented by Shri Take Rike AE (PWD) Namsai Division, with an authorization letter from the PIO.

Heard the Appellant;

The Appellant stated before the Commission that the PIO did not provide the information(s) within the stipulated time as provided under RTI Act 2005. Therefore, he preferred 1st appeal before the First Appellate Authority who is the Chief Engineer (PWD) E-Zone, Govt. of Arunachal Pradesh.

After hearing the appeal the First Appellate Authority (FAA) on 26/11/2025 passed an order directing the PIO to provide the Appellant all the information completely as applied within 15th days of the receipt of the order of the First Appellate Authority (FAA). But being not receiving the information from the PIO even after the order of the First Appellate Authority (FAA), the Appellant filed this second appeal before the Arunachal Pradesh Information Commission (APIC).

Heard the representative of the PIO,

The representative of the PIO stated that he has been provided many information copies by the PIO to be handed over to the Appellant but he is not clear as to what information have been provided as there are two appeal being heard today with the same Appellant. The representative of the PIO stated further that given a time extension of 3(three) months, all the information will be provided to the Appellant for the information which have not been brought today. Further requested the court to order the Appellant to receive whatever information have been brought today and the Appellant to go through the information copies and let the PIO be known as to which of the information are not provided in those set of information that have been brought today.

After hearing both the parties, the Commission hereby order;

- i) The PIO to properly go through the Form 'A' of the Appellant and thereby compile the information properly and index it and thereafter send copies of the information through registered post at the given address of the Appellant or else after the information copies are ready to call up the Appellant to collect the information copies from the office of the PIO, in person.
- ii) The PIO to provide the complete information as ordered in Sl. No (1), above within 3(three) months from today.
- iii) The Appellant to attend the next date of hearing without fail, **failing which this appeal shall be heard and determined ex-parte.**
- iv) The PIO to provide all the information(s) to the Appellant on or before the next date of hearing and to attend the next date of hearing without fail, **failing which appropriate action shall be initiated against the PIO as per the provisions of the RTI Act 2005.**

The next date of hearing has been intimated to both the parties.

Notice need not be issued to the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 18th August 2026 at 2.30 PM.
