SUMMON

WHEREAS, in connection with the **APIC-No. 33/2026**, your personal appearance is required before the Commission on **23rd July, 2026 at 10:30 AM**. The 1st hearing held on **12th May' 2026**. The Appellant Shri Tamchi Gungte is present during the hearing before the Commission.

The PIO-cum-EE, PHE & WS, Hawai Division, Anjaw District, Govt. of Arunachal Pradesh is absent without reporting the reason for his absence.

Heard the Appellant;

The Appellant stated that PIO had written a letter to him on dated 18.12.2025 to deposit an amount of Rupees 82,155/- (rupees eighty two thousand one hundred fifty five only) as the fees for the information, but there was no mention of the total number of pages, and therefore, the fees was not paid.

In the absence of the PIO the fact as presented by the Appellant could not be ascertained, and therefore, giving "the fair chance to be heard" to the PIO, this court hereby pass the following orders;

1. Send Summons to the PIO to attend the next date of hearing without fail, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
2. The Appellant to be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.
3. Send the notice for the next date of hearing along with the Summons to the PIO.
4. Notice for the next date of hearing need not be sent to the Appellant as he is present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 23rd day of July' 2026 at 2:30 PM (Evening).
