**WARNING SUMMON**

WHEREAS, in connection with the APIC-No. 499/2025, your personal appearances required before the Commission on **28<sup>th</sup> July 2026 at 02:30 PM**. The 2<sup>nd</sup> hearing held on **19<sup>th</sup> May 2026**. The Appellant Miss Bengia Mama is present during the hearing before the Commission.

- i) **Warning Summons** be issued to the PIO to be present in the next date of hearing in person or through online mode without fail, failing which appropriate action will be initiated against the PIO as per the provisions of the RTI, Act, 2005.

- ii) The Appellant to be present in the next date of hearing in person or through online mode without fail, failing which this appeal will be heard and determined ex-parte.
- iii) Notice for next date of hearing need not be issued to the Appellant as she is present during the hearing.

**The Commission hereby orders;**

**The next date of hearing be fixed on 28<sup>th</sup> day of July' 2026 at 2:30 PM (Evening).**
