2). **Whereas**, the Commission is satisfied that there are reasonable grounds to hear and dispose of the said appeal under the provisions of the Right to Information Act, 2005. 4). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte. If the PIO is found absent, penalty under section 20(1) of the RTI Act, 2005 shall be invoked against the PIO and in case the Appellant remains absent the case would be disposed of instantly during the 1st hearing.
