SUMMON/ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Chow Lajamang Mannow for non-furnishing of 14(fourteen) information regarding Work Charged (W/C) Staff under the establishment of EE (PWD) Changlang Division by the PIO o/o the EE (PWD) Changlang Division, Changlang District as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 07.08.2025.

This appeal was listed and heard on 10th April, 2026 wherein both the appellant, Shri C.L. Mannow and the PIO, Er. Shri N.Chiliang, E.E were present in person.

This Commission after hearing the appellant who that he has received the requested information / documents from the PIO but did not receive the documents at Sl. Nos. (f), (g),(h), (i), (j) and (k) as also upon hearing the PIO who submitted that the above left out documents/information are not held by his office but by the office of the SE, Namsai who made the recruitment, concluded that as required under section - 7(8)(i) of the RTI Act, when an information is denied to the applicant, the reason thereof has to be communicated to the applicant to his satisfaction. And as mandated by section-18(3)(c) and under rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005, the PIO has to furnish the reasons by way of an affidavit. The PIO was, hence, directed to furnish his submission as above in an affidavit within 1(one) month from the date of receipt of the order dt. 10.04.2026 and the appellant was also directed to intimate the receipt of the same within same timeline.

This Commission, however, received letter dt.12.05.2026 from the appellant (copy reproduced hereunder) complaining that the PIO did not comply with the order of this Commission.

"Respected SIR,

With reference to the Memo No. cited above I went to PIO-cum- EE PWD, Changlang Division (photo enclosed). But, to my utter surprise and dismay nobody was their during Office hours. Till date I have not receive the remaining RTI information(s) as per your Order.

Therefore, I request your hon'ble Court to fix next date of hearing between me (appellant) and respondent(Shri Nani Chiliang, PIO-cum-EE PWD, Changlang Division) in your Court.

In view of the complaint of the appellant as above, this Commission, deems it appropriate to hear the PIO again and accordingly, this appeal is listed again on 05.06.2026 In the meantime the PIO is directed to comply with this Commission's earlier order and report compliance thereof on the date of hearing.
