A. Particular of information: c/p protection wall on Bolek WRC Field at Paya Village of West Siang district, A.P from 2021 to till.

11. The copies of the recorded Date of Commencement and Date of Completion. If the project is delayed, provide copies of any "Extension c Time" (EOT) granted.
12. Provide copies of Inspection Report or "Tour Note" field by the Executives Engineer of Superintendent Engineer regarding their visit to this specific site at Paya Village.
13. Photograph of before, during and after completion of work.
14. Geo tagging details.
15. Quality control reports submitted by the departmental officers during or after construction.
16. Quality test report.
17. The current physical and financial progress percentage of the work as per office records.

18. Completion certificate.

C. Period for which information is required: 2021 to till date.
