SUMMON

- ii) The Appellant to be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.
- iii) Send the notice for the next date of hearing along with the Summons to the PIO.
- iv) Notice for the next date of hearing need not be sent to the Appellant as he is present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 23rd day of July' 2026 at 2:30 PM (Evening).
