SUMMON

WHEREAS, in connection with the **APIC-No. 60/A/2026**, your personal appearance is required before the Commission on **29th October, 2026 at 10:30 AM**. 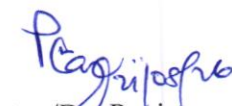
