WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 500/2025**, your personal appearances required before the Commission on **28th July 2026 at 02:30 PM**. The 2nd hearing held on **19th May' 2026**. The Appellant Miss Bengia Mama is present during the hearing before the Commission.

- ii) The Appellant to be present in the next date of hearing in person or through online mode without fail, failing which this appeal will be heard and determined ex-parte.
- iii) Notice for next date of hearing need not be issued to the Appellant as she is present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 28th day of July' 2026 at 2:30 PM (Evening).


