**ORDER**

The 2<sup>nd</sup> hearing held on 7<sup>th</sup> April, 2026' related to the APIC\_No-573/A/2025. The Appellant present during the hearing, the PIO –cum EE UD & Housing Koloriang Division represented by APIO Shri Bamang Amar, AE –cum APIO.

**Heard the Appellant;**

The Appellant stated that despite the order from this court to provide him the information pertaining to Sl. No. 1,5,8,13,14 & 25 have not been provided to him.

**Heard the APIO;**

The PIO stated before the Commission that the office of the PIO, could not get the order from the court of the Arunachal Pradesh Information Commission (APIC) and so there has been delay in providing the said information(s) to the Appellant. But on behalf of the APIO submitted before the court that the above listed information will be provided to the Appellant within 1(one) week time from today that is, on or before 16/4/2026.

**After hearing both the parties the Commission hereby orders;**

- i) The PIO to provide the information on or before the 16/4/2026 without fail, **failing which necessary action as provided under RTI Act 2005 will be initiated against the PIO.**
- ii) The Appellant to collect the information from the office of the PIO in person on or before the 16/4/2026 without fail.
- iii) The PIO to attend the next date of hearing without fail to ascertain the furnishing of information to the Appellant.
- iv) The Appellant to be present in the next date of hearing without fail, failing which this court will presume that he has got all the information from the PIO and will **hear and determine this appeal ex-parte.**
- v) Notice need not be issued to the parties as they are present during the hearing.

**The Commission hereby orders;**

**The next date of hearing be fixed on 23<sup>rd</sup> June' 2026' at 2:30 PM**
