SUMMON

WHEREAS, in connection with the **APIC-No. 908/2025**, your personal appearances required before the Commission on **15th September 2026 at 02:30 PM**. The 2nd hearing held on 7th July' 2026. The Appellant Miss Bengia Mama, present during the hearing and PIO-cum O//o Arunachal Pradesh Building & Other Construction Workers Welfare Board (APV & OCWWB) Itanagar, is absent but a letter addressed to the Appellant a copy submitted to Arunachal Pradesh Information Commission (APIC) for information on date 02/06/2026 giving in written that all the information applied by the Appellant have been furnished to the Appellant.

Heard the Appellant.

The Appellant stated that out of the 9(nine) information applied the office of the PIO has provided her the information for **sl.no-1,8 & 9** only but the rest information applied under Sl. No. **2,3,4,5,6 & 7**, have been replied to her in the form of Annexure Numbered -C and mentioned as not available with the office of the PIO.

The Commission going through the information replied and provided to the Appellant found that the information applied under Sl. No.-**2,3,4,5,6 & 7** of the form 'A' of the Appellant have been replied as not available with the office of the PIO.

The PIO has not given the reason as to why and how, the information as applied are not available with the office of the PIO, whereas a line of clarification for the reason for the non availability of information had to be clarified to the Appellant.

Now therefore, to ascertain the reason for the non-availability of the said information the presence of the PIO in the court of the APIC is warranted and therefore, **the Commission hereby pass the below orders;**

- i) The PIO to be present in the next date of hearing without fail, to clarify the reason why the information applied by the Appellant are not available in his office. Further the PIO is summoned to appear in the next date of hearing without fail,

failing which necessary action as provided under RTI Act 2005 shall be initiated against him.

- ii) The Appellant to be present in the next date of hearing without fail, failing which the court of the Commission will presume that she is no more interested to pursue this appeal and therefore, **the Commission will hear and determine this appeal ex-parte by way of disposing and this appeal.**
- iii) **To send summon to the PIO** to be present in the next date of hearing

The Commission ordered;

The next date of hearing be fixed on 15th Sep'2026 at 2:30 PM.
