**An Appeal Case U/S 19(3) of RTI Act, 2005**

**Case No. APIC-820/2025.**

**(Summon to appear in person)**

**(Or.5 R.3 of CPC)**

**APPELLANT** : Shri Tamchi Gungte, near KV-II School Chimpu Itanagar,

**RESPONDENT** : The PIO, o/o the Director of TRIHMS, Naharlagun.

**ORDER/SUMMON**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 11(eleven) point information regarding c/o "Establishment of New Medical College attached with District/ Referral Hospitals (Tomo Riba Institute of Health and Medical Science, Naharlagun by the PIO, o/o the Director of TRIHMS, Naharlagun as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 21.07.2025.

This appeal was, heard 3 (three) times on 13.03.2026, 10.04.2026 and 29.05.2026 and following orders were passed:

- (a) On 13.03.2026, upon noticing that the documents/information against the appellant's queries needed to be provided satisfactorily to the appellant, the PIO was directed to comply with the requirement of law that if he does not hold any of the requested documents, he shall furnish an appropriate *reply to that effect in an affidavit as required by law under section-7(8)(i) r/w section-18(3)(c) of the RTI Act, 2005 and under rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005* and report compliance therewith on 10.04.2026.
- (b) On 10.04.2026, this Commission after perusing the remaining information/replies brought in the by the PIO, further directed the PIO to furnish the left out information and/or the affidavit **within 1(one) week from the date of receipt of order 10.04.26 and intimate this Commission.**
- (c) On 29.05.26 the PIO did not appear due to his pre-occupation in inspection of the TRIHMS conducted by the National Board of Examination in Medical Science (NBEMS). The PIO was, hence directed to be present on 08.06.25 with the affidavit as directed earlier.

The hearing was, however, held on 11.06.2026 wherein the PIO accompanied by the FAO, TRIHMS as well as the appellant were present. As directed, the PIO brought in the left out information including the Cash Book for inspection by the appellant.

During the course of hearing the FAO explained to the appellant the procedure/ mode of payments to the contractor/firms being followed in the TRIHMS which is through the PFMS mode. The appellant was, hence, satisfied largely with the information / replies to his query at Sl.No.2 (the copy of memo of payments containing the particulars of cheque, vouchers etc. with the copies thereof).

In the premises as above, the appellant was directed to go through the rest of the documents/information furnished by the PIO and report the shortcoming, if any, thereon to this Commission on or before 18.06.2026.

The appellant, vide his letter dt.13.07.2026 (as reproduced hereunder), has now complained that the PIO did not furnish the remaining documents/information and pleaded for direction to the PIO to furnish the remaining information.

"Respected Sir,

*With utmost respect, I am writing to inform you sir that as per the hearing conducted at your chamber at 8<sup>th</sup> June, 2026, the PIO was directed to furnish the remaining document to the appellant. But, still I haven't receive any documents from the PIO. Therefore, I request the honorable Court to fix another date of hearing and direct the PIO to fix another date of hearing and direct the PIO to furnish the remaining documents.*

In the premises as above, the PIO was directed to furnish the left out information or furnish appropriate replies on an affidavit as required by law and report the compliance on 19.08.26, the next date of hearing to avoid penal action.

Today on 19.08.2026, none of the parties attended the hearing though the appellant has informed this Commission vide his letter dt.18.08.2026 that due to his pre-occupation in SIR hearing, he shall not be able to attend the hearing today and requested for adjournment of the hearing.

The hearing of this appeal is, therefore, adjourned to 30.09.2026 and in the interim, the PIO is directed to furnish the requested information to the appellant and report the compliance thereof on 30.09.2026.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
