2. Tender will be opened on 23rd June 2026 (Tuesday) at 1500 hours (3 PM) in the presence of the Board Members in the Office of Registrar, Arunachal Pradesh Information Commission, Itanagar.
3. Tenderer who intends to be present at the time of opening of the tenders may do so.

Tender must be accompanied by a Demand Draft of ₹ 12,000/- (Rupees Twelve Thousands) only and drawn in favour of **Arunachal Pradesh Information Commission, Itanagar**, payable at SBI Branch Itanagar as earnest money which will be refundable in case of unsuccessful bids. The earnest money will be adjusted towards the final payment in case of successful tenderer and will be retained till the deal is finished.
