Information sought:

The appellant has filed an RTI application dated 08.10.2025 seeking following information regarding C/o "Plan & non Plan works/ projects sponsored by state fund/ Central fund or both (such as SIDF/BE/RE/RIDF/SADA/ADA/MLALAD/MPLAD/SPA/Article 275(1)/PMJVK/CRIF / PMDevine/NEC/NESIDS/Non-BADP/ SASCI /PMGSY/ FMBAP maintenance work etc.), executed under the concern division" from the financial year 2015 -16 to 2025-26.

Particulars of sought information are given below: -

1. Copy of Total list of works/projects Completed (Plan & Non-Plan) in which the Security Deposits has been refunded to the contractors (submitted in FDR etc. and deducted from each running bill and final bill @ 2.5% minimum, of the gross amount of Bill) under the division for each financial year from 2015-16 to 2025-26 with proper date of completion details.

2. Copy of Register of Security Deposit Form CPWA 67 maintained in the Division from the financial year 2015-16 to 2025-26 in respect of serial no. 1 mentioned above for each financial year from 2015-16 to 2025-26.
3. Copy of Refund of Security Deposit (along with supporting documents of refund) to the Contractors as per agreement made in Forms CPWD 7 & 8 on the completion of works regulated by Clause 17 of GCC in respect of serial no.1 mention above for each financial year to 2025-26.
4. Furnish all the above documents with CTC & proper manner (i.e. in serial wise with properly Index, proper paging of each financial year and separate books for each financial year for easy & better understanding).

The following were present.

Appellant : Present. He states that information not received from the PIO in spite of order passed by FAA on 22.12.2025

Respondent PIO : Shri Taro Hage, APIO attended through VC. He states that information is kept ready for delivery to the appellant.

Judgement order copy was not available on record. On interjection the appellant produced a copy Judgement order of the FAA.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the FAA - Chief Engineer (E/Z) WRD, Miao, has directed the PIO to furnish the information within 45 days from the date of his order. The PIO has inordinately delayed in furnishing the information which is unbecoming of a public authority in carrying out the statutory duty under RTI Act, 2005. The PIO is hereby ordered to deliver the information document within two weeks from the date of issue of this order. The appellant is directed to serve a copy of this order to the PIO and collect information and submit a status report of the information received by him to this commission within three weeks from the date of issue of this order.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
