**ORDER**

The 4<sup>th</sup> hearing held on **19<sup>th</sup> May' 2026'** related to the **APIC No-94/2025**. The Appellant Shri Mamu Sono is present during the hearing before the Commission.

The PIO-cum-EE, WRD, Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh is represented by Shri Debia Kojum, APIO-cum-AE, through online mode during the hearing before the Commission.

**Heard the Appellant;**

The Appellant stated that the PIO has not provided any information to him till today.

**Heard the APIO;**

The APIO stated that the Appellant has filed multiple applications seeking various informations, and the office of the PIO is flooded with so many applications from so many information seekers among which the present applicant is also one of them.

The present applicant in particular has filed many applications before the PIO out of which today there is hearing for 4(four) appeals.

Among the four appeals the PIO has compiled the information and brought to the court for furnishing it to the Appellant, the court is requested to let the Appellant receive the same information.

After hearing the both parties the Commission order the APIO to handover the information brought and the Appellant to receive the same and go through the information, if the information are provided complete as per his application.

With the above observation and order the court of the Commission further order;

- i) The Appellant to receive the information brought by the APIO and go through it and let the Commission know whether the information are provided completely or not in the next date of hearing.
- ii) The Appellant to be present in the next date of hearing to apprise the Commission the complete receipt of the information or not.

- iii) In the failure of the Appellant to attend the next hearing the Commission will presume that the Appellant has got the complete information, and therefore, this appeal will be heard and determined ex-parte, by disposing of this appeal.
- iv) The PIO to attend the next date of hearing without fail to hear from the Appellant the receipt of the complete or not and failing to attend the next hearing the Commission will initiate necessary action against the PIO as per the provisions of RTI, Act, 2005.
- v) Notice for the next date of hearing need not be sent to both the parties as they are present during the hearing, today.

**The Commission hereby orders;**

**The next date of hearing be fixed on 28<sup>th</sup> day of July' 2026 at 2:30 PM (Evening).**
