**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Munmun Khimhun, PWD-Complex, Nadipar, Changlang, Changlang District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum- EE(PWD), Changlang Division, Changlang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/11/2025 regarding total amount transaction under Er. Nani Chillang, EE(PWD), Changlang Division for various works.

2). **The 1<sup>st</sup> hearing was held on 12<sup>th</sup> May' 2026.** Shri Nani Chiliang, PIO -cum- EE(PWD), Changlang Division, Changlang District, Arunachal Pradesh was present in person before the court. The Appellant Shri Munmun Khimhun appeared before the Commission through online video conferencing.

3). The Appellant informed the Commission that the information furnished were incomplete. The following information were not furnished:-

- (a). Certified copy of all kinds of payment made from EE PWD, Changlang Division,
- (b). Certified copy of work Charged (W/C) / Contingency / Casual staff recruited till date, and
- (c). Certified copy of how much amount is specifically applicable to deduct from Firms / Contractors/ individuals from the bill payment for MLA, EE, AE,& JE.

4). The PIO submitted that for sl.no. (a), the applicant need to seek specific information. The information sought at sl.no. (b) were not available in office, as the office of the Executive Engineer does not conduct recruitment. Lastly, information sought at sl.no. (c) is superfluous.

5). The Commission directed the Appellant to make a list of specific information for sl.no. (a) and submit to the PIO under intimation to the Commission. For information sought at sl.no. (b) the Appellant was advised to approach appropriate recruiting authority, i.e. office of the Superintendent Engineer (PWD) or office of the Chief Engineer (PWD). The Commission also directs the office of the Superintendent Engineer (PWD) and the office of the Chief Engineer (PWD) to furnish information as and when the Appellant approaches the office. For information sought at Sl.no. (c) the Appellant was advised to lodge complaint with appropriate authority with evidence, if required, as the PIO was not in a position to respond to hypothetical queries.

6). The Commission directed the Appellant to submit list of specific information and collect information from the office of the PIO within fifteen days from the date of issue of this order. The Appellant was also directed to intimate his satisfaction or dissatisfaction after receipt of information to the Commission.

7). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant failed to intimate to the Commission within ten days from the expiry of above time given, the case would be disposed of.


