ORDER

The 1st hearing held on 21st May' 2026' related to the APIC No-68/A/2025. The Appellant Shri Tako Heyo is present during the hearing before the Commission.

The PIO-cum-DLRSO, Tato, Shi-Yomi District, Govt. of Arunachal Pradesh is present through online mode during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that some of the information in regard to his Form-A pertaining to Tato-I have been given to him but some of the information(s) are still pending and the information(s) have not been properly compiled and annexed further they are not signed by the PIO as true official copy.

Heard the PIO;

The PIO stated that he has provided the information regarding Tato-I and still some information(s) left to be provided to the Appellant for the same project. The PIO assure the court that he will provide remaining information regarding Tato-II as applied by the Appellant, on or before the next date of hearing of this appeal.

After hearing both the parties the Commission hereby orders;

- i) The PIO to provide the remaining information relating to Tato-I and compile and provide the information relating to Tato-I project on or before the next date of hearing.
- ii) The Appellant to be present in the next date of hearing without fail, failing which this court will presume that he has received the complete information from the PIO, and thereby, this appeal will be heard and determined ex-parte.
- iii) The PIO to be present in the next date of hearing without fail to ascertain that the information have been completely furnished to the Appellant.
- iv) Notice for the next date of hearing need not be sent to both the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 30th day of July' 2026 at 10:30 AM (Morning).
