Information sought:

The appellant filed an RTI application dated 17.08.2024 seeking following information regarding PMKSY-WOC 2.0-11/2021-2022 at Langro, Koduk valley and Nibi under Nyobia circle.

Furnish the following documents within 30 days

1. Furnish the Technical sanction order copy.
2. Furnish Name & Address of contractors/firm/name of Firm owner/Proprietor.
3. Furnish the NIT copy (if possible).
4. Furnish the details bid documents of contractor (Technical & Financial)
5. Furnish Name of work with Geo-tag report of each project.
6. Details of Payment with money receipt of contractors i.e cheque book, counterfoil/deposit challan.
7. Give account statement of department.
8. Give DPR copy.
9. Give MB Book.

10. Give First and Final Bill.
11. Give Photocopy of work site from starting to end/Certified photocopy of work site by concern officer.
12. Furnish all the documents in Certified True copy

Relevant facts emerged during hearing:

Previous Hearings:

1st hearing : 04.08.2025
2nd hearing : 03.10.2025

Order of the 2nd hearing- *"The Commission has observed that FAA – Deputy Commissioner, Koloriang has heard the first appeal on 02.05.2025 and directed PIO to furnish information to the appellant within seven days. Today the PIO is absent without any prior intimation to this commission. Therefore, the case is heard ex parte and the PIO – BDO Sangram is directed to furnish the information to the applicant within ten days from the date of issue of this order under intimation to this commission. The appellant shall serve a copy of this order to the PIO and obtain the information from him and submit a status report to this commission."*

The following were present.

Appellant : Present. He stated that he has not received any information from the PIO till now.

Respondent PIO : Absent. Shri Bamang Taba EO (RE) represented the PIO. He agreed to furnish information to the appellant within 1 week.

FAA : Absent.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records observes that the PIO has not complied with the Commission's order dated 30.10.2025 in which the PIO was directed to furnish information to the appellant within 10 days. However, the representative of PIO has agreed to furnish the sought information to the appellant within one week.

Thus, the PIO is directed to furnish information to the appellant within one week from the date of issue of this order. The appellant is also directed to submit a status report of information furnished by the PIO to this Commission within two weeks from the date of issue of this order.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
