ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pisa Tapam for non-furnishing of 22(twenty two) point information in respect of the following six roads under VVP: 2023-24 by the PIO, o/o the E.E (RWD), Layang Yangte Division, Kurung Kumey District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 26.06.2025.

1. L021-Road from Nyolo to Buhan
2. L027-Rd from 2.5 Km Pt of Koloriang-Tabumhard to Sollung Tapin
3. L022 Road from Buyang to Chimpu
4. L023-Road from Buyang to Degging-1
5. L-028 Road from Buyang to Tate (Raktepu)
6. L026 - Road from Tabumha to Naji Bobok
7. L024 Road from BRTF road to Kachanjane
8. L025-Road from Nijubobok to Kiodhriang

This appeal has been listed for 3(three) times on 06.03.2026, 22.04.2026 and 22.05.26.

On 06.03.26, this Commission, after hearing the parties, more particularly, the APIO, Er. Shri Yangbiu Loka, AE, o/o the Sangram PWD Division who submitted that the documents pertaining to this appeal are with the Koloriang Division as the particulars of schemes mentioned in the RTI application of the appellant comes under the jurisdiction of RWD, Koloriang Division and also upon perusing letter dt. 3rd February, 2026 requesting this Commission to transfer the appeal in question to the PIO, o/o the EE, RWD Koloriang Division, directed the PIOs of both the Laaying Yangte and the Koloriang Divisions to be present in the next hearing fixed today on 22th April, 2026 with the records / evidence of handing over and taking over of the charges of records/documents pertaining to schemes falling under the jurisdiction Koloriang Division to determine as to whose office shall furnish the requested information/documents to the appellant.

On 22.04.2026, however, none of the PIOs appeared. Therefore, the hearing had to be adjourned again to 22.05.2026.

Today on 22.05.2026, the PIO, Laying Yangte Division, Er. Shri Nani Tapa, EE is present in person while the PI, Koloring Division, Er. Shri Nending Bath, EE appeared through VC. The appellant, Shri Pisa Tapam also attended the hearing through VC.

Heard the parties.

The PIO, Laying Yangte Division reiterated his office's submission that in view of handing of the documents to Koloriang Division, the PIO, Koloriang Division be directed to furnish the requested documents/information to the appellant. This Commission records its appreciation that the PIO, Koloriang Division has readily agreed and assured to furnish the requested documents/information to the appellant within 1(one) month.

In the premise as above, the PIO, o/o EE, Koloriang RWD Division shall, henceforth, take all required action to furnish the information to the appellant within one month from the date of receipt of this order and consequently, the PIO, Laaying Yangte RWD Division shall no longer be the PIO in respect of this instant appeal. The appellant is directed to intimate this Commission of the receipt of the information documents from the PIO, o/o the EE RWD Koloriang Division within 1(one) week of the receipt of the same failing which this appeal shall stand closed without further notice.
