**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Abang Yangfo and Shri John Bagang, C/o Raja Biswas Cyber, Model Village, Near Govt Hr. Secondary School Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum-BDO, CD Block Sawa, East Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 17/11/2025 regarding ( i) C/o CC step at Bodo GPC, (Amount 55.38 lakhs) and (ii) C/o Fish Pond at Venia (Amount 55.38 lakhs).
- 2). **The 1<sup>st</sup> hearing was held on 12<sup>th</sup> May' 2026.** The PIO -cum-BDO, CD Block Sawa, East Kameng District, Arunachal Pradesh was represented by Shri Chegu Yangfo, Account CD Block Sawa, East Kameng District through online video conference. The Appellant Shri Abang Yangfo was present in person in the court.
- 3). The Appellant informed the Commission that till date the PIO had not furnished any information.
- 4). The representative of the PIO informed the Commission that the PIO Shri Yagam Marde had left for Aalo to attend the Hangpang Dada Football tournament and asked him to attend the hearing. The representative of the PIO submitted that due to bifurcation of CD block information sought by the Appellant were not held in their office. However, the information had been received from the Chayang Tajo and that the information were kept ready for collection by the Appellant. However, the information were not furnished to the Appellant due to non submission of BPL card and the fee for the information amounting to Rs. 12, 000/- (Rupees twelve thousand only).

- 5). The Commission admonished the representative to apprise the PIO that the statutory duty took priority over other commitments. Non compliance of the Court's summon is tantamount to contempt of court, for which penal provisions under the RTI Act 2005 could be invoked. The PIO is hereby cautioned not to repeat such act of negligence in future.
- 6). The Commission, under section 7(6) of the RTI Act directed the PIO to furnish all the available information to the Appellant free of cost within fifteen days from the date of issue of this order.
- 7). The Commission also asked the Appellant to intimate his satisfaction or dissatisfaction after receipt of information.
- 8). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant failed to intimate to the Commission within ten days from the expiry of above time given to the PIO, the case would be disposed of.
