An Appeal Case U/S 19(3) of RTI Act, 2005

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Suman Gupta for non-furnishing of below mentioned information by the PIO, o/o the Mission Director, National Health Mission, Naharlagun Govt. of A.P as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 29.09.2025.

A. Particular of information: regarding employment under National Health Mission, Govt. of A.P of Dr Rajesh Gupta (Gynecologist), register with Assam Medical Council, bearing Assam Medical Council Registration No.-22884.

B. Details of information required:

1. Whether the said doctor was permitted to work under the govt. of assam and draw a regular salary of Rs 65,000 per month simultaneously during the period of his employment with NHM, Arunachal Pradesh also.
2. Whether the said doctor was permitted to do private practice during the period of said employment.
3. Whether the said doctor had officially disclosed regarding his employment and remuneration received monthly from government of Assam and/or private practice during the period of his employment with NHM, Arunachal Pradesh at the same time. If yes, please provide a copy of official communication regarding the same.
4. Please provide the official duty roster of the said Dr Rajesh Gupta.
5. Kindly comment on the nature of his job particularly with respect to how many days a week/month the said Dr Rajesh Gupta was actually providing the services.
6. Please provide the attendance details of the said Dr Rajesh Gupta.
7. Details of all the health camps that Dr Rajesh Gupta has been officially requested to attend and details of all the remuneration paid for the same. Please provide official copy of such requests.
8. Name of the account holder(s) and account number(s) to whom the salaries for the said employment of Dr Rajesh Gupta were being credited to during the entire duration of his employment with Government of Arunachal Pradesh.
9. Kindly provide the details of when were the first and last salary drawn for his services during employment with Government of Arunachal Pradesh. Kindly refer to the relevant information as disclosed in the RTI reply of Assam government attached herewith this application for your reference and perusal.

Brief facts emerging from the appeal :

Records emerging from the appeal disclose that the appellant, Dr Suman Gupta had requested the PIO, o/o the Mission Director, National Health Mission, Govt of Arunachal Pradesh, Naharlagun, 791110 for the aforementioned information / documents.

The appellant, apparently, having failed to obtain the information / replies from the PIO, filed 1st appeal before the First Appellate Authority under Section 19 (1) of the RTI Act, 2005 vide her Memo of Appeal dt. 25.11.2025. There is, however, no record of the FAA's taking any action on the appeal. Hence, this 2nd appeal before this Commission under section 19 (3) of the RTI Act 2005 vide her Memo of appeal dt. 24.01.2026.

Hearing and decision

This appeal is, accordingly, listed for hearing in this Commission today on 22nd May, 2026 and the appellant, Dr Suman Gupta was heard through Mobile phone who reiterated her demand for the requested information from the PIO. This Commission, however, received information from the Director (NHM), Naharlagun that all the records/information pertaining to the RTI queries of the appellant are held by the o/o the DMO, Changlang and not by the o/o the Director, NHM, Naharlagun and as such, the appellant be directed to obtain the replies /information from the PIO, o/o the DMO, Changlang. The Director, NHM, however, submitted that no permission was granted to Dr. Rajesh Gupta to work under the Govt. of Assam during the period of his employment under the NHM, Arunachal Pradesh nor was he granted permission to do private practice. He also stated that the said doctor did not disclose the fact of his employment under the Govt. of Assam during his employment with NHM, Arunachal Pradesh.

This Commission, upon perusal of the queries as listed in her RTI application dt.29.09.2026, notices that one of the queries (No.7) regarding the details of health camp attended by Dr. Rajesh Gupta, is repetition of her query in her earlier RTI application 08.06.26 (No.2) the reply to which has already been directed to be furnished in the appeal No.APIC-91/2026. As such no direction is warranted in respect of the said query in the instant appeal (Apic-179/2026).

In the light of above discussion, the DMO-cum-PIO, Changlang is directed to furnish the replies to the query Nos. 4,5,6,8 and 9 to the appellant within 4(four)weeks from the date of receipt of this order and the appellant shall intimate this Commission of the receipt of the same within 1(one) week thereafter failing which this appeal shall stand closed without further notice.
