ORDER

The 2nd hearing held on 25th August' 2026, related to the APIC No 851/A/2025 (Appeal). The Appellant Shri Aru Laa present during the hearing and the PIO-cum-Executive Engineer (RWD) Raga Kamle present during the through online mode.

Heard the Appellant.

The Appellant stated that out of the multiple information that he has sought from the PIO, the PIO has furnished in-sufficient information to him while not providing the complete information.

Therefore, the Appellant submitted before the Commission and prayed that the Commission order the PIO to provide the complete information to him before the next hearing.

Heard the PIO.

The PIO stated that as the 5 Nos of works for which the Appellant has applied information are special maintenance works for which there is no tender done and soother related documents are not needed to award the work due to the exigency of road block to be cleared on time work, needs quick and prompt execution and therefore, such works are awarded in work order form for which the trading license, Firm Registration is only need to be awarded work to be completed on time.

Hence, all the information available with the office of the PIO have been provided to the Appellant except the contractor enlistment copy and trading license of the firm that was engaged executing the above 5 special maintenance works.

After hearing both the parties the Commission hereby order ;

- i) The PIO to provide the information pertaining to enlistment of contractor registration certificate and trading license of the contractor /firm which was awarded works on work order basis. The rest information sought by the Appellant are hereby excluded to be provided by the PIO as they are not required in executing the above 5 woks and some of the information like ST/Voter ID Card//Pan Card/ Aadhaar Card are personal documents that require the permission of the individual to provide his/her personal documents to a third party.
- ii) The PIO to write to the individual whose personal documents have been sought by the Appellant whether he is willing to let the office of the PIO furnish those personal documents to the Appellant or not.

- iii) The letter to the individual whose permission is needed to provide his personal information to the Appellant be served a copy to the Appellant as well as the reply copy of the individual also be made available to the Appellant.
- iv) The total amount of payments made to the said firm be furnished to the Appellant before the next date of hearing.
- v) The Appellant to collect the information from the office of the PIO in person when the PIO intimates the Appellant that the information are ready at the office of the PIO.
- vi) The Appellant to be present in the next hearing without fail, **failing which the court will presume that the PIO has provided the Appellant with complete information as ordered above and therefore, this appeal will be heard and determined ex-parte.**
- vii) The PIO to provide the above ordered information before the next hearing and to be present in the next hearing without fail, **failing which disciplinary action against the PIO will be initiated as per the provision of RTI Act 2005.**
- viii) Notice need not be sent to both the parties as both parties are present today in the court and in the know of the next date of hearing.

The Commission hereby orders;

The next date of hearing be fixed on 5th Nov 2026 at 10:30 AM (Morning)
