ORDER

The 2nd hearing held on **19th May' 2026'** related to the **APIC No-769/A/2025**. The Appellant Shri Mamu Sono is present during the hearing before the Commission.

The PIO-cum-EE, PWD, Seppa Division, East Kameng District, Govt. of Arunachal Pradesh is represented by Shri Hinda Rimo, APIO-cum-AE, through online mode during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that he has not been provided with any information from the PIO till today.

Heard the APIO;

The APIO stated that the information(s) have been compiled for the Appellant and readied at the office of the PIO and further it was also sent to the office of the First Appellate Authority (FAA)-cum-SE, Sagalee Circle, but the Appellant has not turned up to collect the information for which the PIO had written a letter to the Appellant on 23.10.2025 and again on 05.03.2026 to collect the information but the Appellant has neither responded the letter nor come to collect the information and that is why the pendency to provide the information to the Appellant till now.

After hearing both the parties the Commission hereby orders;

- i) The PIO to send the information through Registered Post at the address of the Appellant.
- ii) The Appellant to be present in the next date of hearing to let the Commission know that he has received the information from the PIO or not, without fail and failing which, this court will presume that the Appellant has received the complete information, and thereby, this appeal will be heard and determined ex-parte.
- iii) The PIO to be present in the next date of hearing without fail, to ascertain from the Appellant, if the information sent to the Appellant are complete as applied by the Appellant, failing which, necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.

- iv) Notice for the next date of hearing need not be sent to both the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 28th day of July' 2026 at 2:30 PM (Evening).
