ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Dr. Karge Riram, s/o Lt Mr Tokar Riram, R/o Liru Village, PO & PS Likabali, Lower Siang District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, O/o Deputy Commissioner, Likabali, Lower Siang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 10/03/2026 regarding establishment of the permanent District Hq.

2). **The 1st hearing was held on 18th August' 2026.** Shri Choge Nyodu, PIO-cum-DLRSO, O/o Deputy Commissioner, Likabali, Lower Siang District, Arunachal Pradesh and the representative of the Appellant, Adv. Marge Lombi appeared before the Commission through online video conferencing.

3). The PIO submitted that the information were kept ready and the Appellant was asked to collect information. However, the Appellant failed to collect information from the office.

4). The representative of the Appellant submitted that the intimation was served to the Appellant to collect information only after receipt of summon notice from the Commission. The PIO had also asked the Appellant to pay fee of Rupees Four only, which was in violation of the RTI Act.

5). The Commission directed the PIO to furnish information free of cost to the Appellant as the PIO had not furnished information within prescribed time.

6). The Commission asked the Appellant to collect information from the office of the PIO within two days from the date of issue of this order and intimate his satisfaction or dissatisfaction. The next course of action would be decided on the basis of intimation from the Appellant. In case the Appellant failed to intimate to the Commission within ten days from the date of issue of this order the case would be disposed of.
