Information sought:

The appellant filed an RTI application dated 25.02.2025 seeking following information regarding C/o road from Piyong to Nongtaw Shyam, phase-I (CH: 12000 to 19500=7.50 Km)

Details of the Information required-

- Certified copy of Sanction Memo. Of the said work /scheme.
- Certified copy Administrative Approval and expenditure Sanction (AA&ES) copy.
- Certified copy of Technical Sanction (TS) copy.
- Certified copy of NIT in local daily newspaper with name of newspaper/date.
- Certified copy of Name of the firm, contractor, sub-contractor who is doing the said work before calling of NIT i. e 07/02/2025.
- Certified copy of authorization letter from competent authority who allowed the firm/contractor/sub-contractor to execute the work before completion of tender processing.

- g) Certified copy of any rules and terms & conditions in where it is mentioned that before calling of Tender processing, work can be started, that is mentioned in CPWD Works manual.
- h) Certified copy of Name of all the firms who participated and submitted the Bids
 - (a) Technical Bids
 - (b) Financial Bids
- i) Certified copy of Name of the firms qualified in technical Bid and Participated in the Technical and Financial Bids along with Comparative Statement.
- j) Certified copy of Board Members of the Tender processing.
- k) Certified copy of Bank solvency Certificated of the firm who did the work/scheme.
- l) Certified copy of Affidavit of having not more than 2(two) works in hand under the state govt by the firm.
- m) Certified copy of videography photograph with Global Positioning System (GPS) Co-ordinates/Geo-tag of the said work before calling of NIT and after it.
- n) Certified copy of Design & Drawing of the work /scheme.
- o) Certified copy of Name of EE/AE/JE Who executed the said work /scheme/project.
- p) Certified copy of status copy of the work.

Relevant facts emerged during hearing:

Previous Hearings:

1st hearing : 09.02.2026

Order of the 1st hearing- *"The Commission has observed that the PIO has furnished some information to the appellant and the FAA has also heard the appeal and disposed of the appeal case on 02.07.2025 with a direction to PIO to furnish remaining information to the appellant. It seems the appellant was satisfied with the explanation given by the PIO as per judgement order of FAA regarding item no. (f) & (g) of Form A. The PIO & the appellant was also directed to fixed a suitable date for inspection of work, documents etc as asked by the appellant and agreed by the PIO. Therefore, the FAA's judgement order is upheld. The PIO is directed to comply with the FAA's Order dated 02.07.2025 within two weeks from the date of issue of this order i.e. on or before 23.02.2026."*

The following were present.

Appellant : Present through VC. He stated that they have inspected the project site as per Commission's order dated 09.02.2026 but the PIO has not furnished the remaining information to him.

Respondent PIO : Present through VC. He agreed to furnish the remaining information to the appellant within 2 weeks.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes that the PIO has complied with the Commission's order dated 09.02.2026 and now he is ready to furnish the remaining information to the appellant within 2 weeks from today.

The PIO is directed to furnish the remaining information i.e "Certified copy of Affidavit of having not more than 2(two) works in hand under the state govt by the firm" to the appellant within 2 weeks from the date of issue of this order. The appellant is also directed to submit a status report of information furnished by the PIO to this Commission within 3 weeks from the date of issue of this order.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant, this appeal case shall stand closed.
