ORDER

The 1st hearing held on **21st May' 2026'** related to the **APIC No-107/A/2025**. The Appellant Shri Riya Taram is present during the hearing before the Commission.

The PIO-cum-EE, Electrical Department, Tawang Division, Tawang District, Govt. of Arunachal Pradesh is represented by Shri Nima Tsering, AE-cum-APIO during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that he has not been provided with the information by the PIO till today.

Heard the representative of the PIO;

- i) The representative of the PIO submitted before the Court that he has brought the information as applied by the Appellant and on the consideration of the court he is handing over the information copies to the Appellant.
- ii) The Appellant received the information copies from the representative of the PIO in the court.

Under the above procedure and circumstances the Commission hereby orders;

1. The Appellant to go through the information furnished by the PIO and report the Commission whether the information(s) are complete or not in the next date of hearing.
2. The Appellant to be present in the next date of hearing without fail, failing which the Commission will presume that the Appellant has received the complete information from the PIO and thereby this appeal will be disposed of ex-parte in the event of the failure of the Appellant to attend the next hearing.
3. The PIO to be present in the next date of hearing to ascertain whether the information have been completely furnished to the Appellant or not.
4. Notice for the next date of hearing need not be sent to both the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 30th day of July 2026 at 10:30 AM (Morning).
