ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Vijay Pertin & Shri Kalom Perme, Ithili Village, PO/PS Roing, Lower Dibang Valley District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum- DMO, Roing, Lower Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/10/2025 regarding **information on MPW interview conducted by DMO, Roing.**
- 2). The 1st hearing was held on 31st March' 2026. Dr. Worar Taku, PIO -cum- DMO, Roing, Lower Dibang Valley District, Arunachal Pradesh and the Appellant Shri Vijay Pertin were present.
- 3). The Commission had directed the PIO to make a list of all the twenty four candidates who had qualified for the interview with their address and contact number, a separate list of selected eight candidates, and check if all the answer scripts were available in the office records and intimate to the Commission within thirty days from the date of issue of this order. Also, the PIO was directed to submit copy of letters served to third parties and copies of replies there-to to the Commission.
- 4). The PIO vide Memo No. LDVM/RTI/2026-27/370-71 dated Roing the 23rd April'2026 complied with the Commission's directions.
- 5). The Commission under section 19(4) of the RTI Act 2005 decided to summon the third parties for the hearing.
- 6). **The next date of hearing is fixed on 7th July'2026 (Tuesday) at 11.00AM.**
- 7). Therefore, Dr. Worar Taku, PIO -cum- DMO, Roing, Lower Dibang Valley District, Arunachal Pradesh, and all the 8(eight) selected candidates are hereby summoned to appear before this Court in person on the scheduled date and time without fail. Also, the 16 (sixteen) candidates qualified for Viva-Voce, but not selected, are hereby directed to give their response in writing to the Commission before 7th July'2026.

8). Take notice that in case of default in appearing on the day of hearing mentioned a appeal will be heard and determined ex-parte. If the PIO is found absent, penalty under s 20(1) of the RTI Act, 2005 shall be invoked against him and if any of the third party are found absent or do not respond till 7th July'2026, it will be presumed that the person do not have any objection in disclosure of their information. Also, if the Appellant is found absent the case would be disposed of.

Order copies be issued to all the parties.


