ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Kipa Natung & S hriT ami Pangu for non-furnishing of below mentioned information by the PIO, o/o the District Land and Revenue Office as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 09.10.2025.

1. Furnish CTC of allotments/ LPCs along with Sketch Map of the above-mentioned lands allotted to Shri Chowna Mein and his Spouse/ Wife.
2. Furnish the CTC copy of NoCs and Forest Clearances issued against all the above-mentioned allotted lands.

Part-A-Un-Disclose Assets in Election Affidavits.

1. Furnish detail of all the properties (Agricultural, Non-Agricultural, Residential and Commercial lands) other than disclosed assets, registered against Shri Chowna Mein, DCM of Arunachal Pradesh or his wife at your office establishment till date.
2. Furnish detail of all the properties (Agricultural, Non-Agricultural, Residential and Commercial lands) registered against children of Shri Chowna Mein, DCM of Arunachal Pradesh, at your office establishment till date.

3. Furnish CTCs of land allotment/LPCs along with Sketch Map & required NoCs/Forest clearances of all the lands allotted to the children of Shri Chowna Mein, DCM of Arunachal Pradesh at your office establishment till date.

Brief facts emerging from the appeal :

Records emerging from the appeal disclose that the appellants, Shri Kipa Natung and Shri Tame Pangu had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to appeal before the Deputy Commissioner, Namsai District, Namsai, Govt. of Arunachal Pradesh, the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 10.07.2025 However, the appellants having failed yet again to obtain the information preferred 2nd appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of Appeal dt. 30.01.2026 .

This appeal is, accordingly, listed for hearing in this Commission today on 20.05.2026 wherein the PIO, Shri Kago Doni attended the hearing through VC but the appellants are absent without any intimation.

During the course of hearing the PIO submitted that FAA conducted the hearing on 4th Feb. 2026 and directed the PIO to furnish the sought for information available in the office of the District Land Revenue & Settlement Officer. Namsai to the appellants free of cost by 13/02/2026. The extract of the FAA's order dt. 04.02.26 is reproduced hereunder:

In compliance with the order of the FAA, the PIO, vide letter dt. 4th Feb. 2026 (as reproduced hereunder), had furnished the requested documents to the appellants.

The PIO submitted that the appellants were furnished with the requested documents/information but they expressed dissatisfaction saying that the information were incomplete but the appellants did not mention specific points/ queries against which the information were incomplete.

In the absence of the appellants, this Commission could not ascertain as to the shortcomings in the documents/information furnished by the PIO in view whereof this Commission deems it appropriate to direct the appellants to furnish to the PIO within 2(two) weeks from the date of receipt of this order the points against which replies/information were incomplete and the PIO shall, within 15 days, thereafter, furnish the documents with an intimation to this Commission. The appellants shall, within 1(one) of the receipt of the documents/information, intimate this Commission failing which this appeal shall stand closed.
