ORDER

The 3rd hearing held on 27th August' 2026, related to the APIC No 862/A/2025 (Appeal). The Appellants Shri Donik Roru and Shri Gichik Topar, both present during the hearing.

The PIO -cum -Executive Engineer (PWD) Palin Division Kra-Daadi District, Govt of Arunachal Pradesh, present during the hearing in person.

Heard the Appellants.

The Appellants stated before the Commission that the PIO has not provided them the information till today.

Heard the PIO.

The PIO stated before the Commission that whatever information as applied by the Appellants have been brought in the court to be furnished to the Appellants. The copy of the information to be furnished to the Appellants exhibited before the Commission and the PIO requested, the Commission to order the Appellants to receive the information copies from the PIO in the open court.

After hearing both the parties the Commission hereby order;

- i) The Appellants to receive the information from the PIO and go through it and to let the Commission know whether the information as provided by the PIO are complete or not, in the next hearing.
- ii) To ascertain that the information are complete or not the Commission to hear this appeal one more time, wherein the PIO is ordered to be present in the next date of hearing without fail, **failing which disciplinary action against the PIO shall be initiated.**
- iii) The Appellants to go through the information as provided by the PIO and to let the Commission know in the next hearing whether information provided by the PIO are complete or not.
- iv) Notice for the next date of hearing need not be sent to both the parties, as both the parties are present and witness to the pronouncement of the next date for hearing in the court of the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 3rd Nov 2026 at 2:30 PM (Evening)
