ORDER

The 5th hearing was held on 3rd August, 2026 related to the **APIC No-639/A/2025 (Appeal)**. Appellants Shri Takar Jamoh present in person and the PIO-cum-ADC, Namsai present through VC.

On the 3rd hearing dated 4/2/2026, PIO stated before the Commission that query no. 5 (b) the clarification has been sought from the SJETA Department query for Sl. No. C, there is no proper guidelines/rules for issuance of the PRC they are seeking clarification from the higher authority/ Government. PIO also stated that the appellant has applied for PRC by surrendering his original PRC of East Siang District. The query made by the appellant is relating to issuance of PRC on surrendering original PRC.

Today the Commission received a letter from the Deputy Secretary-cum-PIO, Political Department, Govt. of Arunachal Pradesh addressed to JTO-cum-PIO, SJETA stating that Political Department does not have any Notification/Guidelines/Rules/Records/Files pertaining to PRC matters of the bona-fide indigenous Scheduled Tribe of Arunachal Pradesh.

Political Department deals with the PRC matters related to non-APST only such as Ahom, DEori, Mishng/Miri, Adivasi, Moran, Kachari, Gorkha settlers, Karbi Tribes etc. temporarily residing in Papum Pare, Lohit, Namsai, Changlang, Districts of Arunachal Pradesh.

PIO requested the appellant to visit her office to short out the issue regarding his issuance of PRC.
