Information sought:

The appellant filed an RTI application dated 19.09.2025 seeking following information regarding C/o Total list of Completed work/project sponsored by the State fund/Central fund of both SIDF/BE/RE/RIDF/SADA/ADA/MLALAD/MPLAD/SAP/Article275(1)/PMJVK/CRIF/PMDeVine/NE C/NESIDS/Non-BADP/SASCI/JJM/NRDWM/SBM, Maintenance work etc. from the financial year 2016-17 to 2025-26.

Details of Information required:

1. Furnish the certified copy of Total list of work /project completed by the division under various scheme head mentioned above (state/central scheme or both as mentioned above), for each financial year from 2016-17 to 2025-26.
2. Furnish the certified copy of Sanction order/Administrative Approval (AA) & Expenditure sanction (ES) of each completed project in respect of serial no.1 mentioned above for each financial year from 2016-17 to 2025-26.

3. Furnish the certified copy of Technical Sanction (TS) of each completed project in respect of serial no 1 mentioned above for each financial year from 2016-17 to 2025-26.
4. Furnish the certified copy of Agreement made between the Contractor and Executing Agency, for each completed project/works from the financial 2016-17 to 2025-26.
5. Furnish the certified copy of work order (with amount mentioned) issued to the contractor with respect to serial no.1. (only for the work awarded in work order form) 2016-17 to 2025-26.
6. Furnish the Details of fund Surrendered to the Govt. Head Account in respect of serial no. 1 of my form-A
 - a) Remaining balance amount after AA, ES and TS has been done. (Enclosed the proof of surrender such as challan copy or whichever method has been used.)
 - b) Remaining balance amount after TS and contract agreement/work order amount of the project/works. (Enclosed the proof of expenditure)
7. Furnish the details of expenditures of fund if been utilised, in respect of serial no 1. Of my Form-A.
 - a) Remaining balance amount after AA, ES and TS has been completed. (Enclosed the proof of Expenditure).
 - b) Remaining balance amount after TS and contract agreement/work order amount of the projects/works. (Enclosed the proof of Expenditure).
8. Furnish the certified details of officer (Name & Designation) who authorized/approve the surrender process of fund in respect of derail no.6 of the Form-A.
9. Furnish the certified details of Officer who authorized/approve the expenditures of fund in respect of serial no. 7 of Form-A.
10. Furnish the rules followed by the Division officer (under CPWD works manual/ any other etc.) that authorize the officers to make an expenditure of fund beyond the contract agreement/work order amount in respect of the projects/works.
11. Furnish all the above documents with CTC & proper manner (i.e. in serial wise with properly index and proper paging of each financial year).

The following were present.

Appellant : Absent

Respondent PIO : Absent. Shri Osem Monku, Astd. Engineer cum APIO represented the PIO. He states that the RTI application in form A is not received.

Decision:

The Commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the APIO, observes that the FAA cum Chief Engineer, PHED (E/Z), Namsai heard the appeal case on 16.01.2026 but both the appellant and PIO were absent. Thus, he has taken ex-parte decision and disposed of the appeal case without any further direction. The appellant has filed a written submission dated 16.3.2026 that he could not attend the hearing in the FAA as he received the hearing notice late. The APIO states that the RTI application in form A is not received. The appellant was absent in today's hearing without intimation of reason for it.

The appellant is directed to serve a copy of this order along with a copy of his RTI application in form A to the PIO within one week from the date of issue of this order and obtain written acknowledgement. The PIO is directed to furnish the information as sought for within three weeks upon receipt of this order from the appellant.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
