An Appeal Case U/S 19(3) of RTI Act, 2005

Case No. APIC-384/2026.

APPELLANT : Shri Buli Bhai, G-Sector TR Complex Nlg.

RESPONDENT : The PIO, o/o the EE (WRD) Ziro, Lower Subansiri, Distt.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Buli Bhai for non-furnishing of below mentioned information by the PIO, o/o the EE (WRD) Ziro, Lower Subansiri District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 20.02.2026.

A) Particular of information : C/O MIP at Siikhe Bogo Myolang under PMKSY (HKKP). Amounting Rs.1,64,61,000/- (One Crore Sixty-four Lakhs Sixty-one Thousand) only.

Facts emerging from the appeal and decision:

The records in the appeal reveal that the appellant, Shri Buli Bhai, vide his RTI application dt. 20.02.2026, had requested the PIO for the aforementioned information but failed to obtain the same which prompted him to file his 1st appeal before the Chief Engineer (WRD) Western Zone, Itanagar, the First Appellate Authority (FAA) under section 19(1) of the RTI Act via his Memo of Appeal dt.04.04.26.

The records in the appeal, however, do not indicate as to whether the FAA had conducted the hearing and passed any order thereon but the appellant, vide his Memo of Appeal dt.19.05.2026, has preferred his 2nd appeal before this Commission under section 19(3) of the RTI Act, 2005 on the ground of non-furnishing of requested information.

This appeal is accordingly, listed today on 21.08.2026 wherein the appellant, Shri Buli Bhai is present in person while the PIO is represented by Er. Shri N. Tade, A.E who submits that on receipt of the RTI application from the appellant, the o/o the PIO had asked the appellant to explain some discrepancies noticed in the BPL certificate submitted by the appellant for obtaining the requested information free of cost but the appellant did not respond, instead he preferred his 2nd appeal before this Commission.

Since the FAA has not heard and adjudicated on the appeal as mandated under section 19(1) of the RTI Act, this appeal is a fit case to be remanded to the FAA for adjudication and passing an appropriate order.

This appeal is, therefore, remanded to the FAA, the Chief Engineer (WRD), Western Zone Itanagar, for adjudication and passing an appropriate order in speaking form after conducting a proper hearing and affording adequate opportunity of hearing to both the appellant and the PIO within 30(thirty) days from the date of receipt of this order. If the appellant feels aggrieved with the decision of the FAA, he may come back to this Commission for consideration and adjudication under section 19(3) of the RTI Act, 2005.
