ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, Po/Ps Chimpu, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO -Cum- EE(PWD), Anini Division, Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/12/2025 regarding Plan & Non-Plan Works / projects sponsored by State fund / Central fund (such as SIDF/ BE/RE/ RIDF/SADA / ADA / MLA-LAD /SPA/ Article 275 (1)/ PMJVK/ CRIFK/ PMDeVINE/ NEC / NESIDS / Non-BADP /SASCI /FMBAP / CMSRPD/ Maintenance works etc, executed under the division : from the financial year 2023-24 to 2025-26.

2). The 1st hearing was held on 7th July' 2026 (Tuesday) at 1100 hrs. Shri Millo Tade, Assistant Engineer (PWD), Anini-Division Dibang Valley District, A.P. and Shri Tamchi Gungte, the Appellant were present.

3). Information was handed over to the Appellant. Having received the information the Appellant requested the Commission to give him time to go through it.

4). The Commission giving two weeks time had asked the Appellant to intimate his satisfaction or dissatisfaction.

5). The Appellant vide letter dated 05/08/2026 informed the Commission that the PIO had not furnished complete information and submitted a list of incomplete information. The Commission in view of the letter decided to fix a date of hearing.

6). The next date of hearing is fixed on 29th September 2026 (Tuesday) at 11 AM.

7).Therefore, the PIO -cum- EE(PWD), Anini Division, Dibang Valley District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

8). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
