An Appeal Case U/S 19(3) of RTI Act, 2005

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pisa Tapam for non-furnishing of 22(twenty two) point information in respect of the following six roads under VVP: 2023-24 by the PIO, o/o the E.E (RWD), Layang Yangte Division, Kurung Kumey District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 26.06.2025.

- 1) L021-Road from Nyolo to Buhan
- 2) L027-Rd from 2.5 Km Pt of Koloriang-Tabumhard to Sollung Tapin
- 3) L022 Road from Buyang to Chimpu
- 4) L023-Road from Buyang to Degging-1
- 5) L-028 Road from Buyang to Tate (Raktepu)
- 6) L026 - Road from Tabumha to Naji Bobok
- 7) L024 Road from BRTF road to Kachanjane
- 8) L025-Road from Nijubobok to Kiodhriang

This appeal was listed for 3(three) times earlier on 06.03.2026, 22.04.2026 and 22.05.26.

On 22.05.2026, wherein the PIO, Laying Yangte Division, Er. Shri Nani Tapa, EE was present in person and the PIO, Koloriang Division, Er. Shri Nending Bath, EE appeared through VC.

This Commission, after hearing the PIO, Laying Yangte who submitted that in view of handing of the documents to Koloriang Division, the PIO, Koloriang Division be directed to furnish the requested documents/information to the appellant which the PIO, Koloriang Division, as readily agreed to, had concluded that the PIO, o/o EE, Koloriang RWD Division shall, henceforth, take all the required action to furnish the information to the appellant within one month from the date of receipt of order dt.22.05.26. The appellant was also directed to intimate this Commission of the receipt of the information /documents from the PIO, o/o the EE, RWD Koloriang Division within 1(one) week of the receipt of the same.

This Commission, however, received letter dt. 01.07.2026 from the appellant, Shri Pisa Tapam that the PIO, RWD (Koloriang Division) did not furnish a single documents despite this Commission's order.

Therefore, vide order dt.02.07.2026, the PIO, RWD (Koloriang Division) was again directed to furnish the requested information to the appellant and report the compliance thereof to this Commission on 31.07.2026, the next date of hearing.

On 31.07.2026, the appellant, Shri Pisa Tapam was present in person but the PIO, Er. Shri Nending Bath, EE was absent without any information nor did he furnish the information as directed by this Commission and also assured by him.

This Commission, taking a serious view of the PIO's non-compliance of this Commission's order and non-appearance in the hearing which amounted to wilful and blatant disrespect to this Commission and the RTI regime on the part of the PIO attracting penal action under section 20 of the RTI Act, 2005, warned the PIO vide order 31st July, 2026 not to compel this Commission to impose the prescribed penalty under section 20(1) of the RTI Act, 2005 and directed him to be personally present on 26.08.2026 and explain as to why penalty of Rs.25,000.00 as prescribed under setion-20(1) of the RTI Act should not be imposed upon him for non-compliance of this Commission's order and that the said order shall be treated as show cause notice.

Today on 26.08.2026, the appellant, Shri Pisa Tapam is present but the PIO is absent without any intimation.

Herad the appellant who informed that the PIO has furnished information in respect of schemes at Sl. Nos.(1) to (7) of his application but did not furnish the information with respect of scheme at Sl. No.(8) (L025-Road from Nijubobok to Kiodhriang) but the PIO has assured that he will furnish the information / documents within 1(one) weeks time.

In the view of the submission of the appellant as above, the PIO shall furnish the said left out documents a within 1(one) week from the date of receipt of this order and the appellant is directed to go through the information received so far and to be furnished later by the PIO and intimate the receipt thereof to this Commission within one week from the date of receipt from the PIO failing which this appeal shall stand closed.
