Information sought:

The appellant has filed an RTI application dated 28.01.2026 seeking following information regarding (Package No. III), Arunachal Frontier Highway viz Huri to Taliha under Kra-Daadi district.

Particulars of sought information are given below: -

1. Furnish the MB (Measurement book) of all the affected families of land owners.
2. Furnish the payment method like Xerox copy of the Cheque leaf/pay in slip for NEFT/RTGS/PFMS.
3. Furnish the money receipt/payment list of affected land owner with their Aadhar card/PRC/ST/contact number.
4. Furnish the first & final bill copy of all the materials/areas of land.
5. Furnish the technical sanction (TS) copy of the entire above-mentioned project.
6. Furnish the order copy & financial resolution of meeting with meeting attendance list.
7. Furnish the sanction order copy for land compensation of village wise.
8. Furnish the Land compensation assessment copy of village wise.
9. Furnish the Land acquisition notification copy.

10. Furnish the claim & objection of land acquisition & compensation notification copy.
11. Furnish the selected list of affected land owners in village wise with their contact number.

The following were present.

Appellant : Absent. However, he has submitted a letter dated 18.08.2026 for rescheduling of hearing date stating that he would be busy at (SIR) Special Intension Revision at Tali.

Respondent PIO : Present. He states that he has been furnishing information documents to the affected individuals as per provision of RTI Act, 2005.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the PIO, observes that the FAA – Deputy Commissioner, Palin has heard the appeal case on 30.03.2026 and passed judgement order with a direction to the PIO to furnish required information sought to the appellant within 7 days from the date of issue of his order. The FAA has not yet disposed of the 1st appeal case filed to him from his end.

This appeal is remanded to the **FAA - Deputy Commissioner, Palin**. He shall ensure the implementation of his judgement order dated 30.03.2026 and dispose the case from his end within three weeks from the date of issue of this order under intimation to this commission. The appellant shall serve a copy of this order to the office of the FAA- Deputy Commissioner, Palin, obtain written acknowledgement and submit a copy of it to this commission.

The appellant is at liberty to approach this commission:

1. If the Appellant is not satisfied with the information furnished to him by PIO based on the judgement order passed by the FAA.
2. If the FAA has denied the requested information based on specific exemptions/ grounds provided under the RTI Act, 2005.
