**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Wangnon Wangnow, Forest Colony Longding, District Longding, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE( RWD), Govt. of A.P., Department of Rural Work, Longding Division, District Longding, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/02/2025 regarding Road from 1.54 km point of BRTF Konnu to PMGSY Road to Khonsa.
- 2). The 4<sup>th</sup> hearing was held on 31<sup>st</sup> March' 2026. Shri R.W. Zimik, the PIO-cum-EE (RWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh, and the Appellant Shri Wangnon Wangnow had appeared before the Court through video conferencing.
- 3). The PIO vile Memo No. LRWD/ESTT/RTI-01/2025-26 dated 13<sup>th</sup> April'2026 informed the Commission that the Appellant's mobile always remain switched off and was unable to contact him. Further submitted that the Appellant repeatedly sought the same information which had already been furnished.
- 4). The Appellant informed the Commission that instead of furnishing information, the PIO had instigated third party to withdraw the appeal. The Appellant also submitted a copy of letter served to him by the third party, requesting him to withdraw the RTI appeal. The Appellant also appealed the Commission to take action against the PIO under the provisions of the RTI Act 2005 and compensate him under section 19(8)(b).
- 5). The Commission decided to fix a date of hearing to facilitate both parties to justify their respective stand.

5). The next date of hearing is fixed on 9<sup>th</sup> June'2026 (Tuesday) at 11am.
